## **Executive Director and Chief Litigation Counsel**

The Arizona Center for Law in the Public Interest (ACLPI) is a private, non-profit, public interest law firm dedicated to representing the people of Arizona on issues that affect us all, including:

ACLPI seeks to replace its retiring Executive Director and Chief Litigation Counsel. This position has the dual primary responsibilities of (1) managing the Center's advocacy efforts as lead litigation counsel, and (2) leading the Board's fundraising efforts through public, media, and community relations. This position also supervises the Center's staff, which includes two to three staff attorneys, one legal fellow, a fundraising/development coordinator, and a legal assistant, and oversees and/or undertakes recordkeeping, fiscal management, and grant writing functions. The Executive Director and Chief Litigation Counsel will be the primary liaison between the Board and the Center staff.

## **Minimum Requirements**

The successful candidate must: (1) be committed to pursuing the Center's mission, including through fundraising efforts; (2) have significant litigation experience; and (3) be a member in good standing of the state bar where he/she is admitted to practice law; and (4) if not already licensed, be willing and able to obtain a license to practice law in Arizona.

## **Preferred Qualifications**

The ideal candidate will have:

- At least eight years of trial and/or appellate experience;
- Experience in a supervisory role;
- Excellent advocacy skills, including legal research, oral, written, and analytical skills;
- Initiative, persistence, energy, and creativity;
- Excellent organizational skills;
- Ability to work with clients of diverse backgrounds, cultures, and orientations; and
- Capacity and willingness to communicate and work effectively with external audiences and to function as an effective spokesperson for clients and for the Center.

The position is located in the Phoenix metropolitan area. The starting salary for this position is \$140,000-\$160,000 and will be set based on experience. The Center provides excellent benefits, including health and long-term disability insurance, and the ability to participate in a 403(b) program.
